

PROMJENA NAČINA PREDAJE KONKURSNIH RADOVA ZA IDEJNO URBANISTIČKO – ARHITEKTONSKO RJEŠENJE UREĐENJA KORITA I OBALA RIJEKE MORAČE

Stoga, podnošenje konkursnih radova poštom više nije moguće. Radovi moraju biti podnijeti elektronskim putem, na sljedeći način:

Konkursne radove potrebno je dostaviti putem email-a u .pdf formatu na adresu glavni.arhitekta@podgorica.me ne kasnije od ponoći (UTC+1) 14. Decembra 2020. godine. Za slanje radova obavezno je korišćenje posebne email adrese kreirane za tu svrhu i koja se sastoji od sljedećih elemenata:

1. moraca,
2. donja crta (_),
3. odabrane šifre autora i
4. široko korištenih domena.

Molimo učesnike da prilikom slanja dokumentacije vode računa da ista nije veća od 5MB ili da u suprotnom koriste *WeTransfer* link ili ekvivalent.

Prijava, da bi bila ispravna, treba da sadrži tri odvojena foldera sa .pdf fajlovima i to: jedan za A3 svesku, jedan za A0 panele i jedan koji sadrži podatke o autoru/ima. Izvjestioci će po pristizanju konkursnih radova provjeriti dostavljenu dokumentaciju i izdvojiti folder sa podacima o autoru/ima na čuvanje do konačne odluke Žirija.

Učesnici će dobiti email potvrde prijema. Učesnici su u potpunosti odgovorni za sigurnu i pravovremenu dostavu dokumentacije i Glavni grad Podgorica se ne može smatrati odgovornim za neuspjele prijave.

Svi učesnici biće obaviješteni o odluci žirija **28. decembra 2020. godine.**

CHANGE OF SUBMISSION PROCEDURE FOR COMPETITION FOR THE CONCEPTUAL URBAN AND ARCHITECTURAL DESIGN FOR THE DEVELOPMENT OF THE MORAČA RIVERFRONT IN PODGORICA

Due to the problems caused by the COVID-19 pandemic in Montenegro and Europe, we are informing all of the potential participants interested in the Competition for the conceptual urban and architectural design for the development of the Morača riverfront in Podgorica that the submission procedure has been changed.

Thus, the submission via post office is no longer available, while the e-submission procedure is as follows:

The Designs shall be emailed in .pdf format to the following email address: glavni.arhitekta@podgorica.me no later than midnight (UTC+1) on Monday December 14th. It is obligatory to use an email address created solely for the purpose of submitting design which shall consists of:

1. moraca,
2. underscore (_),
3. author's code and
4. wide used domains.

Please be aware that attachments to your email must not exceed 5MB. If they do, we recommend using *WeTransfer* link or equivalent.

The application package must consist of three separate folders with .pdf files: one for A3 booklet, one for A0 panels and one containing information about author(s). Competition rapporteurs will review the application package and store the folder with information about authors separately, until the Jury's ranking list and Decision on the winner.

Competitors will receive an email confirming that their application has been received. Please note: competitors are responsible for the safe and timely delivery of their submissions. Capital city Podgorica cannot be held accountable for undelivered entries.

All participants will be informed about the jury's decision on **December 28th 2020**.
