1. UVOD / INTRODUCTION

Raspis konkursa za idejno rješenje uređenja Park šume Lješkopoljska Gorica u Podgorici, objavljen 18. aprila 2024. godine, definisao je vrstu i visinu nagrada, otkupa, obeštećenja i nadoknada.

The Competition for conceptual design of Lješkopoljska Gorica forest park in Podgorica, which was published on April 18th 2024, defined prizes, honorable mentions, indemnities and compensations.

Ukupan nagradni fond za dodjelu iznosi 49.000,00 eura, a dijeli se na sljedeći način:

Gross prize fund amounts to 49.000,00 €, and it shall be divided in following amounts:

I nagrada / First prize	25.000,00 €
II nagrada / Second prize	12.000,00 €
III nagrada / Third prize	6.000,00 €
Tri otkupa po / Tree honorable mention each	2.000,00 €

Nagrade, otkupi, kao i naknade članovima žirija i izvjestiocima, navedeni su u bruto iznosu.

Prizes, redemptions, as well as compensations to the jury member and reporters, are specified in gross amount.

Žiri zadržava pravo da ne dodijeli neku od navedenih nagrada ukoliko konkursni radovi ne budu na zadovoljavajućem nivou, kao i da ustanovi posebne nagrade i priznanja.

The jury reserves the right not to award any of the listed prizes if the submitted designs are not at the satisfactory level, as well as to establish special awards and notable mentions.

2. ODLUKA ŽIRIJA / JURY'S DECISION

Žiri je izvršio pregled 38 idejnih rješenja. Žiri nije razmatrao radove pod šiframa **1989011**, **Stonebythehill78** i **ps1113** iz razloga navedenih u Zapisniku sa otvaranja konkursnih radova.

The jury reviewed 38 conceptual designs. The jury did not review the designs submitted under the codes **1989011**, **Stonebythehill78** and **ps1113** due to the reasons elaborated in the Opening of competition works - Report.

Na prvoj sjednici žirija najprije je pozitivnom metodom selekcije radova odabrano 27 radova koji su prošli u drugi krug: **1897, PLA_8008, 0PL0PL, MDFBMAP, 19675, 23864, T1Q11, LIOT2336, 124418, 11120, POD4EST, BBELW682644, 78891, 80613,**

WLZCLLAJCDC2024, 24986, 18DCGFM24, 51698, 28109, GPD5842, 95962, 82790, ARHIPELAG, 19392, gaj00, 14750 i 101011.

At its first session, the Jury has used a positive method of selection of works to select 27 designs to pass into the second round of the selection process: **1897, PLA_8008, 0PL0PL, MDFBBMAP, 19675, 23864, T1Q11, LIOT2336, 124418, 11120, POD4EST, BBELW682644, 78891, 80613, WLZCLLAJCDC2024, 24986, 18DCGFM24, 51698, 28109, GPD5842, 95962, 82790, ARHIPELAG, 19392, gaj00, 14750 and 101011.**

Na drugoj sjednici, žiri je odabrao 9 radova koju su ušli u treći krug: **PLA_8008, 0PL0PL, 19675, 124418, 11120, BBELW682644, 24986, 14750 i 101011.**

At the second session, the jury selected 9 designs for the third round of the selection process: **PLA_8008, 0PL0PL, 19675, 124418, 11120, BBELW682644, 24986, 14750 and 101011.**

Nakon diskusija na trećoj i četvrtoj sjednici žiri je odabrao šest radova koji su ušli u uži izbor za dodjelu nagrada i otkupa. Žiri je jednoglasno dodijelio **prvu nagradu** radu pod šifrom **24986**. Većinom glasova žirija **druga nagrada** dodijeljena je radu pod šifrom **101011**, a **treću nagradu** radu pod šifrom **11120**.

Žiri je većinom glasova odlučio da se **tri otkupa** dodijele radovima pod šiframa **PLA_8008, 124418 i 14750**.

After discussions at the third and fourth sessions, the jury selected six works that made it to the final round for the awards and acquisitions. The jury unanimously awarded the first prize to the work with code **24986**. By a majority vote, the second prize was given to the work with code **101011**, and the third prize went to the work with code **11120**.

The jury, by a majority vote, decided that three honourable mentions would be given to the works with codes **PLA_8008, 124418, and 14750**.




